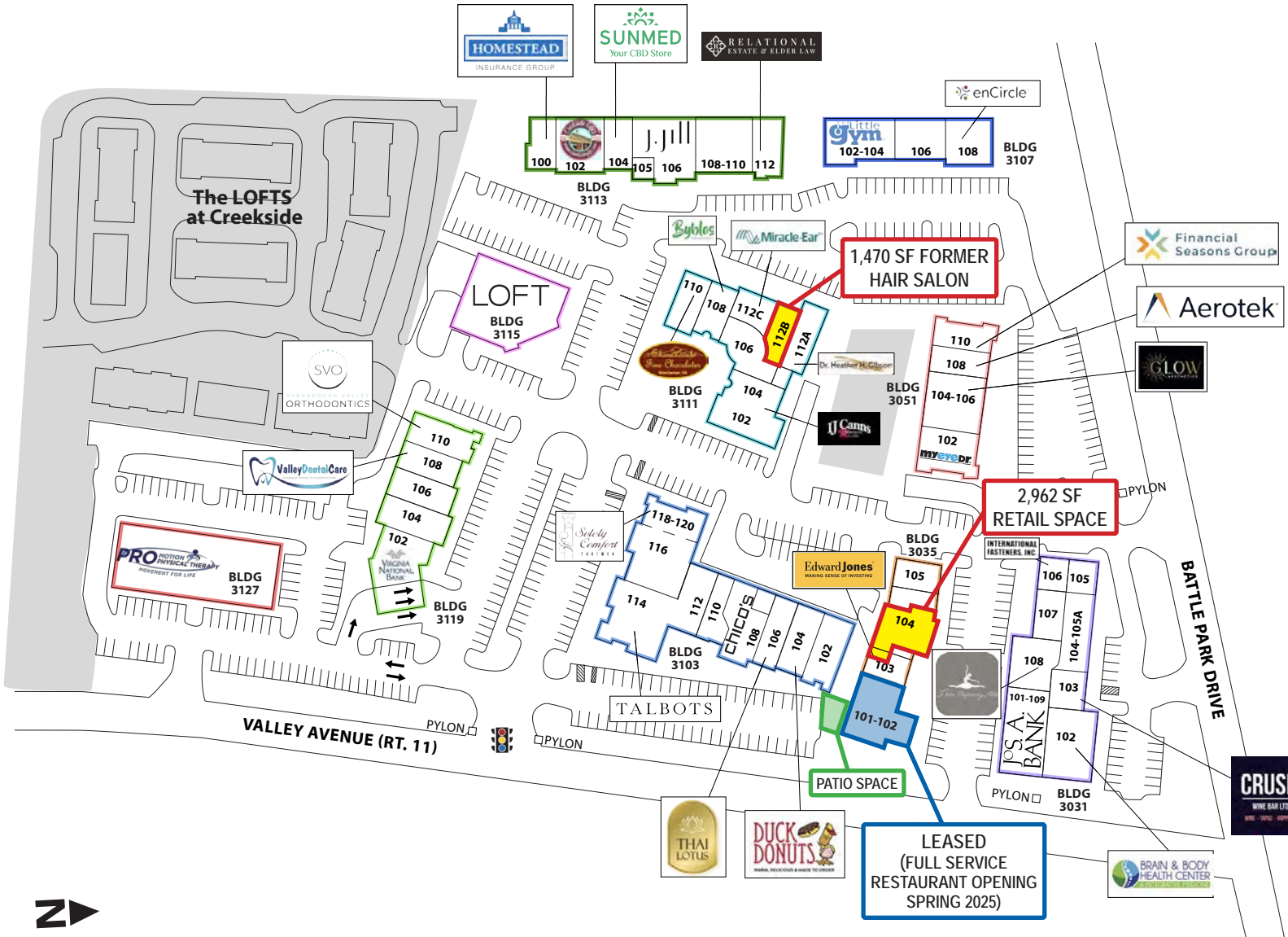
Overview
